**Q: What types of equipment can LifeSpan handle?**

A: LifeSpan provides asset retirement and computer equipment recycling services for all technology assets - from servers and networks to copiers and test equipment. We're a single point-of-contact regardless of equipment type or its manufacturer.

**Q: What does LifeSpan do with the equipment?**

A: Many unwanted technology assets still have remaining economic life, so our first priority is to help our clients obtain value from these assets. Our TCO Recovery™ service is a unique revenue sharing program maximizes the client's return for on its equipment.
