After 24 months (two 12 months periods), customers can acquire a definitive license for one third of the price of a standard license

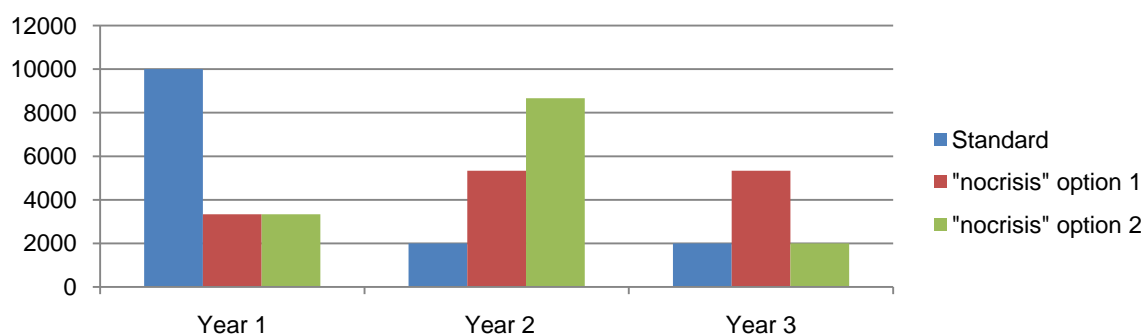
