FINAL JUDGMENT

This cause came before the Court on October 15, 2008 upon the Plaintiff's Motion for Entry of Default Final Judgment and the Court having considered the evidence, testimony and argument of counsel, and being otherwise fully advised in the premises, makes the following findings of fact, based upon the uncontested evidence:

1. Defendant, JOHNNIE JELINEK, JR. made false statements directed towards Plaintiff, which are defamatory per se.
2. Plaintiff did not steal Defendant's invention idea, nor threaten Defendant.
3. Defendant's false and defamatory statements and accusations have significantly harmed Plaintiff's reputation and have dissuaded third parties from conducting business with Plaintiff

4. Plaintiff suffered actual damages by virtue of lost business; to wit, fifty clients declined to enter into contracts with Plaintiff due to Plaintiff's false statements.
5. Plaintiff's damages are further evidenced by Plaintiff's decline in revenue.
6. The accurate and reasonable measure of Plaintiff's damages is half of the loss from ~~the~~ ^{twenty five of the} fifty contracts, which, as a conservative value, caused Plaintiff a loss of \$5,000 per contract.
7. The total amount of damages that Plaintiff has suffered, as evidenced by competent evidence and to a legal certainty, is \$125,000.00.

ORDERED and ADJUDGED as follows:

Defendant, JOHNNIE JELINEK, JR., is found liable for his false and defamatory statements made against the Plaintiff, INVENTION TECHNOLOGIES, INC. The Plaintiff, INVENTION TECHNOLOGIES, INC., 2655 LeJeune Rd, Suite 550, Coral Gables, FL 33134, shall have and recover judgment against the Defendant, JOHNNIE JELINEK, JR., 333 Alcazar Northeast, Apt. C, Albuquerque, NM 87108 in the amount of one hundred and twenty-five thousand dollars (\$125,000.00) with interest at the statutory rate of 11% per annum, for which let execution issue.
