Mission of the Signs of Support Grant Program

We seek to support and strengthen local civic and charitable organizations with donations of signage, graphics and displays at partial or no cost.

Eligibility

Local public schools, non-profits, non-governmental civic organizations, and local affiliates of registered charities located in Fairfield County CT, or Westchester and Putnam Counties, NY (must be within a 15-mile radius of our store location at 35 Eagle Road, Danbury CT)

Your Responsibility; Our Promise

Please read the application (and our tips below) thoroughly before submitting. Submissions must be received no later than midnight, November 30th, 2024. The staff of Signarama Danbury thanks you for your participation in the Signs of Support Grant Program and gives every application serious consideration.

Term

Grants must be applied for annually and are valid for the award year 2025. Signage must be ordered by March 15, 2025. Any unused grants are non-transferable to the following award year.

Application form must be submitted along with a formal estimate from Signarama.

Applicable Types of Signs

Here is a quick guide to the types of signs we provide through the Signarama Danbury Signs of Support Grant Program:

- Facility Signage = Signs around your facility. Examples include: lobby lettering, wall murals, custom wallpaper, vinyl lettering, interior directionals, parking signage, ADA, door signs, decorative banners or displays or POP Signage.
- **Event Signage** = signage that an organization might use for an event like a fundraiser or activity. Examples include: banner stands, trade show displays, standees and photo-op signs, yard signs, golf outing signs, presentation checks, banners, and other temporary and reuseable signage to help promote an event or provide logistics.
- **Identification Signage** = primary signage for your location, identifying your site and who you are. Examples include: post and panel signs, monument signs, building signs, or other type of major identification.
- **Vehicle Graphics** = Your vehicles can be an excellent way to advertise your mission. Examples include: vehicle lettering, removable magnets, and partial and full wraps





Tips and guidelines for submitting a successful application:

- Five (5) Signs of Support Grants are available for 2024.
- Please consider your level of need prior to applying. Our goal is to provide assistance to those organizations with the greatest need. It is not our intent that organizations apply for assistance who already have adequate funding for their signage needs.
- Signarama Danbury reserves the exclusive right to determine grants and awards based on
 the judging committee's best estimation of organizational need and level of benefit to the
 community. All awards are final and cannot be combined with other offers or discounts.
 Signarama Danbury reserves the right to rescind a grant based on failure to put the project
 into production during the specified grant period, inaccurate description and/or
 specifications for signage project provided in grant application, or other impediments to the
 completion of the project not stated in the grant application and beyond the control of
 Signarama Danbury.
- Applications for grants must be submitted annually and are valid only for the award year. Any
 unused grant funds are non-transferable to the following award year.
- An organization may submit one application for any grant cycle, but a single application may contain multiple signs.
- If you are applying for more than one sign in your grant, please indicate which sign or project has a higher priority.
- Grants are awarded for the specific project described in the grant application only, including size, design and materials.
- Grants are in the form of signage and discounts, not monetary awards. The awards are available through Signarama Danbury exclusively and may not be transferred to another Signarama location.
- Applicable municipal zoning and sign permits are the responsibility of the applicant and in some instances, the installation of the signage may be the responsibility of the award recipient.
- Include as much detailed information relating to your request as possible. Attach pictures, drawings, or additional information related to location, purpose, or make note of the appearance of your old sign you are trying to replace. Use additional pages as necessary.
- Include the monetary amount you have available to contribute to the sign project. We are
 more inclined to award partial grants so we can spread our giving out among several worthy
 causes.
- We recommend that you make an appointment (call 203-792-4091 or email info@signarama-danbury.com) to discuss the signs you want. This allows us to provide you with ideas and options for your specific sign needs.
